

RoostNeo26 Offer, Free Apple MacBook Neo

1. The first 300 customers who make a room booking at any Student Roost property for the 2026/27 academic year between 2:00pm BST on 3 June 2026 and 23:59pm BST on 31 August 2026, or until all 300 promotional devices have been allocated, whichever occurs first ("Offer Period"), will receive an APPLE MacBook Neo laptop, subject to these terms and conditions.
2. There are only 300 APPLE MacBook Neo laptops available. This offer is open to new customers, existing customers who currently hold a tenancy agreement with Student Roost for the 2025/26 academic year, and customers booking through an approved Student Roost agent.
